

# International Congress Technology and Elections (Expo ICT)

# Presentation

The Federal Electoral Institute (IFE) is organizing the International Congress on Technology and Elections, in order to know the different alternatives for information and communication technologies (ICTs) that have been implemented in Mexico and other parts of the world, for the development of the electoral process, from the preparation to election day, and then the election results stage.

The topics discussed during the Congress should provide sufficient information for the IFE, citizenship, political actors and the public to be able to analyze the benefits and implications of the use of ICTs in electoral processes from four different dimensions: technological, legal, political and cultural.

The comparison between different international and national experiences on the subject, will serve as input for informed decision-making on the implications of the use of ICTs in any electoral process. The Congress will be open to those who want to know and propose technological solutions to improve our electoral processes considering various opinions and perspectives, as public and private companies, regulators, scholars, national and international electoral authorities.

The topics will be discussed in eight workgroups. Each subject addresses a goal and a question to be answered.

ICT can offer advantages to give speed and greater certainty to the complex procedures involved in modern elections. Therefore, the Congress will have and exclusive area for specialized institutions and companies to present and showcase their technology. This way, everyone will have a comprehensive view of the performance, not only of the performance of technological solutions, but also of the scope of their implementation and results in specific cases.

# Session 1. Voting modalities: in-person (electronic voting machine) and remote (Internet). National experiences

### Objective:

To get to know the legal and technological experience of those local electoral authorities who have implemented electronic voting with binding effects.

# Thematic content that may answer the following question: what is the scenario of the use of technology for voting in Mexican elections?

- Sharing the experience concerning the legal changes and technological development processes of those local electoral authorities who have implemented electronic voting in their elections.
- Determine the level of citizenship acceptance for technology in elections.

- Identifying whether the electoral authorities have mechanisms for the transmission of results, other than those used in federal elections in Mexico, and how these could be implemented in our country.
- Knowing the state-of-the-art on the characteristics of speed, amounts of information, security and cost of data transmission technologies that could streamline the management of information and be used during Election Day.

- Sharing the electoral authorities of other countries' experience that led them to decide not to implement electronic voting any longer.
- Identifying the type of issues faced when using technology in elections, regarding public trust.
- Getting to know the most frequent and common vulnerabilities tan can affect both electronic urns and communication in the transmission of results.
- Identifying experiences where the ICT security was breached and the results obtained.

- Identifying technological options to encourage and facilitate the participation of Mexicans living abroad.
